Professor D. P. Sarkar, Director, IISER Mohali, commented about the need to re-word "re-appointment" to "re-engagement" in the Minutes. This change has been incorporated in the Minutes with the approval of the Chairperson. With regard to the other points mentioned by Professor D. P. Sarkar, they are not pertaining to the Minutes of the 33rd Meeting of the Board of Governors. Further, Professor D. P. Sarkar forwarded his comments on item no. B.O.G.18.33.4 and B.O.G.18.33.6 and B.O.G.18.33.16(4) and (5) to the Chairperson and all the BOG Members on 24.09.2018 whereas; the details about these items are as follows:

With regard to the item No. B.O.G.18.33.4, it is about confirmation of 32^{nd} BOG Meeting last date for the receipt of the Minutes and comments, if any was 19.6.2018. No such comments have been received on this issue up to 19.6.2018. No response from any other members, even at this stage, the point, Professor D. P. Sarkar desires to raise is about the clarification of the MHRD about OCI issue and about prospectively on the Minutes of the 32^{nd} Meeting of the BOG. (Issue about Professor Sanjay Mandal and now the issue stands settled.)

With regard to the item no. B.O.G.18.33.6, Professor D. P. Sarkar was proposing to modify the language of the decision about the adoption of Annual Statement of Accounts. Since, the audit started by the CAG duly accepting the BOG resolution dated 29.8.2018, no changes can be made at this stage.

With regard to the item no. 18.33.16(4), Professor D. P. Sarkar commented about the re-engagement of Professor K. S. Viswanathan and the Director has appointed Professor K. S. Viswanathan as Visiting Professor.

With regard to the item no. 18.33.16(5), the decision of the BOG was to place the proposal again duly examined by the professional expert like C-DAC for buying High Performance Computer, whereas Professor D. P. Sarkar has given justification for buying the HPC as his comments.

With regard to the Item No.18.33.10 :- IISER Mohali is to ensure that necessary permissions are obtained by the NABI/IISER as the bridge proposed is being constructed on the land of the Govt. of Punjab.

With regard to the Item No.18.33.16:- BOG approval may be treated as uniform practice for all Int. Ph.D. and Ph.D. students for six months. The words "first three batches" may be deleted.

With regard to the Item No. 18.33.16(4):-No proposal or details have been received by the MHRD. In view of the indiscriminate usage of earlier BOG-delegated power by the Director, Prof. D. P. Sarkar, all the BOG resolutions in respect of power delegated to the Director have been withdrawn/taken back, effective from this date and until further resolution. Accordingly, BOG decided that proposals for appointment of any visiting professors in all cases be placed to the BOG, after examining from financial angle. The decision will be taken by the BOG on a case-to-case basis.

With regard to the Item No.18.33.16(5):- In the absence of Director IISER Mohali in the meeting, and as recommended by the Finance Committee, the BOG desired to have a detailed presentation on this issue, duly submitting an expert Committee report on the existing HPC purchased earlier and its utilization.

	a. Some of the staff members with grade pay of Rs. 4200/- have been promoted to the grade pay of Rs. 4600/- and from G.P. of Rs. 4600/- to 4800/- through the DPC. Their designations have not been changed. Accordingly, it is proposed to change their designation by suffixing 'Sr' in their designations. For Example i.e. technical assistant in the grade pay of Rs. 4200/- will be designated as a senior technical assistant. There is no financial implication.	
	b. A request received from the Executive Engineer. (Placed at agenda)	
	Executive Engineer cum Estate Officer was recruited in the scale of Rs. 15600-39100 with a grade pay of Rs. 6600/ He was placed in the grade pay of Rs. 7600/- after completion of 5 years in the grade pay of Rs. 6600 (as per the NIT RRs). Now the Executive Engineer is requesting for change of designation as a Superintending Engineer without any change in the scale of pay.	

Decision B.O.G.18.34	Due to inadequacy of time the issue of the Re-designating Executive Engineer Position could not be discussed. However, for the other technical and administrative staff "Senior" may be added to prefix to their existing designations. With regard to the Assistant Engineers (Civil and Electrical) they may be designated as "Assistant Executive Engineer". 4.12 High Performance Computer
	The BOG in its 33 rd meeting held on 29.8.2018 decided that the proposal is to be placed again with the recommendation of the professional experts like C-DAC. Subsequent to the decision in the meeting, the Director, IISER Mohali through his comments informed that the proposal has been made by the experts including professional expert from the C-DAC.
	Further, Director circulated the proposal vide his email dated 15.10.2018 to all the BOG Members and sought approval through circulation. Professor R. S. Dubey and Professor Sarit Kumar Das, Director, IIT Ropar agreed to the proposal. The Chairperson informed all the BOG Members that the availability of the Funds is to be ascertained and the decision to procure Rs. 7 crores worth HPC is yet to be taken and the necessity for constitution of the purchase committee will arise at that stage.

Decision	 Construction of Two Hostels 17193.5 Sq.Mts. (512 rooms) and additional estimated cost of Rs.1.82 crores and approval thereto. The Board of Governors accorded approval to place an application for HEFA Loan to construct two hostels of 512 rooms each at an estimated cost of Rs.61.42 crores, vide agenda Item No. B.O.G.

18.33.08. The cost estimate was prepared by the Executive Engineer
of IISER Mohali based on the plinth area rates prescribed by the
CPWD (20017 rates plus upto date cost index). After submission of
the estimate, the same has been sent to the Chief Engineer (North
Zone-1) Chandigarh for vetting. The office of the Chief Engineer
CPWD modified the estimate due to the change in regulations on
ESI and EPF components and a few components of external services
and thus, the vetted estimate for the construction of the 512 rooms
is amounting to Rs.63.24 crores. This change in the amount of the
estimate took place after approval of the BOG on 29.08.2018.
Accordingly, it is requested to approve and sanction, an additional
amount of Rs.1.82 crores also. Total estimated cost is Rs.63.24
crores.
Though an application for HEFA Loan amounting to 61.42 crores

Though an application for HEFA Loan amounting to 61.42 crores was considered earlier as recommended by the Finance Committee, the BOG decided to have full justification from the Director IISER Mohali for spelling out the reasons why adequate hostels room were not made as per the DPR and also the Master Plans. To this extent, the Director IISER Mohali is to make a presentation explaining the circumstances and reasons for not constructing the adequate no. of students hostel rooms as envisaged in the DPR. Only after furnishing the detailed reasons, circumstances in the presentation this proposal will be considered.

2. Request of the Registrar Dr. P. Bapaiah to reimburse the legal expenses incurred by him in defending the case filed by the Director IISER Mohali against the Chairperson and BOG and Dr. P. Bapaiah as respondents.

Decision Dr. Bapaiah fought the case as a respondent in CWP No. 15762 in the High Court of Punjab and Haryana which is the same case, in

	which the Chairperson (being a first respondent) also engaged an
	advocate and the BOG approved meeting of the expenses of the
	advocate engaged by the Chairperson, and Rs.4 lakhs have been
	paid. The claim of Dr. Bapaiah is for 5.5 lakhs for two cases and the
	first case was filed by him against the erroneous order of the Director
	IISER Mohali suspending Dr. P. Bapaiah. The Board may
	reimburse the expenditure incurred by Dr. P. Bapaiah as a defendant
	in the case filed by him, and expenses incurred by Dr. Bapaiah for
	filing the case against the Director's action may be claimed from the
	Director Prof. D. P. Sarkar. Accordingly, against his claim for Rs.5.5
	Lakhs, Rs.4 lakhs may be sanctioned (equivalent to the amount paid
	to the advocate of the Chairperson for defending the same case).
	Balance amount of Rs. 1.5 Lakhs may be claimed from Professor D.
	P. Sarkar, whose action was responsible for the filing of a court case.
	The amount of Rs. 1.5 Lakhs may be recovered from Professor D. P.
	Sarkar and released to Dr. P. Bapaiah.
	3. MOU with Punjab Pollution Control Board, Vatavaran Bhawan,
	Nabha, Patiala.
	Punjab Pollution Control Board proposes to enter into an MOU
	with IISER Mohali. They may offer some Research projects to be
