| | <p>Landscaping at IISER Campus:</p> <p>The members were informed that the construction work of IISER Mohali as envisaged in the Phase I is near completion, the need for a proper landscaping of the campus has been felt. The members were apprised that since 2009, about 6000 plants have been planted in the green belt area, along the main artery inner road and along the boundary wall. The plants are being irrigated by the treated water generated from STPs and a few shallow bore-wells which had been bored during the construction stage. The committee was informed that the landscape of the IISER Campus have been envisaged on the following lines:-</p> <ol style="list-style-type: none"> 1. The campus shall respect the symbiotic relationship between nature & buildings. |

2. Landscaping shall provide cohesion dovetailing buildings & plants.
3. Landscape elements shall provide linkages & fill the gaps between buildings to highlight courtyards and enclosed spaces.
4. Landscape linkages shall enhance the concept of vehicle free pedestrian movement in the academic plaza.
5. Existing external services like electrical, rain water harvesting, water supply, storm water drainage, distribution of treated water shall be totally integrated with the landscaping.
6. Areas which have been marked for future development shall be so landscaped as to be ready for use as & when required without major interventions.
7. The landscaping shall be graded – that is intense near the buildings which shall gradually decrease when distance increases, that is the intensity of the landscape shall be directly propositional to its nearness to the building.
8. The selection of elements of landscaping shall be such as will need minimum upkeep & maintenance as has been done in building works.
9. The landscaping shall be designed as a whole but shall be executed from part to whole, slowly, integrating areas with one another to enhance the footprint of nature.
10. Landscaping shall be used for creating cool pockets encouraging venturies to improve ventilation system in the buildings and in the spaces around the buildings.
11. The horticulture and arboriculture already in place shall be suitably altered to give a feeling of neatness and urban ambience. However, natural pond & ecogarden space shall be left untouched.
12. Grass tiles shall be used for creating surface parking lots.
13. Play and exercise zones shall be created at appropriate places.
14. Upkeep of landscaped area shall be automated to minimize labour component.

In so far as the implementation is concerned, the committee was informed that the conceptual landscape plan could be obtained by hiring the services of the Consulting Architect (M/s Cosmic Designs) and executing the work through the CPWD. This is because the current Consulting Architect has prepared the Master Plan of the Campus and has all the idea related to the orientation/positioning of the buildings, its detailing, location of services, area of building and the entire zoning of the Campus. The Architect would also have in mind the symbiotic relationship of the environment with the buildings built so far and are likely to be built in future. Therefore, the Consulting Architect will be in better position to understand and conceptualize the landscape plan based on the above listed points and would be eminently suitable for planning the landscaping of the campus. CPWD having completed 85% work of the Campus will be in a position to execute the same by virtue of its past experience and affinity to topography of IISER Mohali campus.

The issue was deliberated by B&WC and the following was recommended for consideration and approval of the Finance Committee and the BoG:-

1. The current Consulting Architect i.e. M/s Cosmic Designs, Lucknow be asked to present his concept plan on composite landscape of IISER Mohali based on the above lines.
