	There is a proposal to set up a Chandigarh Innovation Circle (CIC), by establishing a 'not-for profit' company, promoted by the UT Chandigarh Government.
	1. About the Proposal:
	This proposal has been developed by a team led by ISB Mohali, in consultation with all stakeholders: Academic and R&D institutions, industry representative bodies, Corporates, investors, financial institutions and potential startups and Government officials etc. It is proposed to establish a not-for-profit company under Section 8 of the Companies Act, to function as an independent, autonomous, professionally run organization anchored on sustainable model for collaboration among all stakeholders. Dr. Girish Sahni, Ex-Director General, Council of Scientific & Industrial Research (CSIR) and Secretary DSIR, Government of India, has consented to be the Chairman of the Board of Directors.
	 J.M. Balamurugan, IAS, Principal Secretary to The Governor of Punjab has shared the proposal with the institute and sought the following actions: a. Expression of in-principle willingness for participation as member in the CIC-MILES Board (this will be non-binding).

This consent may be conveyed immediately. b. Formal approval of the proposal by your institution after following the due process in your respective institutions and formal acceptance of membership of CIC.
3. IISER Mohali's proposed plan:
 a. A response has been sent for 2a above and Dean R&D has been nominated to represent IISER Mohali on CIC – Miles Board.
b. With respect to 2b, it is sought that an in-principle approval be given to IISER Mohali for a formal acceptance of the membership of CIC. A summary presentation of the CIC proposal is attached.

(iv) IISER Mohali entering MOU with a Company called RECDESPROT PVT. LTD.

The MoU is to source DNA encoding proteings that of interest to other researchers, by taking these on transfer from different research groups at IISER Mohali, and by thereafter producing and selling the encoded proteins to other laboratories, to commercialize them at milligram scale as research reagents. Royalties will be paid to IISER Mohali for every sale resulting from transfer of DNA as proposed I the draft MoA.

Records of transferes (details of DNA transferred) will be maintained with the office of Dean R & D, IISER Mohali, Production of proteins for sale will be at the company site.

There would be not IPR implication, and none of the materials proposed to be transferred would be patentable in any form,

The proposal appears to be reasonable at first glance, and will provide an opportunity for research groups at IISER Mohali to commercialize some of their research on a small scale.
