Recommendations of the Assessment Committee for Career Advancement Scheme (CAS) for faculty <u>will be placed on the table.</u></p> <p><u>It is submitted for the consideration of the Board.</u></p> <p><u>Comments of the Ministry of Education: Applicability of CAS in IISERs needs to be checked. CAS is normally not followed in the institutions which follow flexi-cadre structure.</u></p> <p><u>Comments of the IFD: CAS is not supported wherever Flexi Cadre structure is there. Approval/clarification may be sought from MoE.</u></p>
	<p>The BoG was informed that the Assessment Committee under CAS had met with Prof. Ajay Sood as Chairperson on 29.07.2022 and that the recommendations have been finalized.</p> <p>In view of the comments of the IFD and Ministry of Education, the applicability of CAS in IISER Mohali was discussed with particular reference to the question of whether the faculty positions belong to fixed cadre or flexi cadre.</p> <p>The Registrar informed that a total of 120 faculty position have been sanctioned to IISER Mohali, out of which the initial 60 positions were sanctioned in fixed cadre (30:15:15) for Asst. Prof.: Assoc.Prof.:Professors), whereas the next 60 positions were sanctioned in flexi cadre.</p> <p>It was further noted that The Central Educational Institutions</p>

	<p>(Reservation in Teachers' Cadre) Act 2019 for faculty positions is to be applied at all the levels. The same can be applied if faculty positions are classified into fixed categories i.e. Professor, Associate Professor and Assistant Professor. Accordingly, it was decided by the Institute that the 120 positions will be classified as under:</p> <ul style="list-style-type: none">• Professors : 15• Associate Professors : 45• Assistant Professors : 60 <p>The same has been communicated to the Ministry in various communications. Subsequently, a roster was prepared, which was approved in the 47th BoG meeting, and hence the faculty positions in IISER Mohali no longer fall in the flexi cadre. BoG members suggested that the Institute should write to the Ministry of Education clearly indicating the situation as stated above.</p>

However, DoPT as per its guidelines No.39020/01/2013-Estt(B)-Part dated 31.12.2015, has discontinued the interview for non-Gazetted, Group 'B' as well as Group 'C' Employees.</p> <p>The BoG is requested to guide the Institute on whether the Institute should conduct interviews for non-gazetted B and C posts as per Statutes or conduct the selection based on written tests and skill tests as per DOPT guidelines.</p> <p><u>It is submitted for the consideration of the Board.</u></p> <p><u>Comments of the Ministry of Education: The institute has to follow DoPT guidelines consistent with the concerned positions, under which interviews have been done away with for Non-Gazetted Group 'B' and Group 'C' posts.</u></p> <p><u>Comments of the IFD: The guidelines of DoPT may be followed to maintain uniformity. In Statute, there is a provision of seletion committee but DoPT rules does not allow interview in Group 'B' and 'C'.</u></p>

	In its 48 th meeting held on 26-05-2022, the BoG was informed that the existing arrangements for boys and girls to stay in separate wings within each of four hostel buildings have resulted in detection of several serious infractions involving unauthorized presence of individuals in rooms and

	<p>corridors of the opposite gender that have consequently led to disciplinary cases as well as complaints filed with the Committee against Sexual Harassment / Internal Complaints Committee.</p> <p>After discussions, the Board resolved in the 48th meeting that there shall be mandatory gender segregation for 1st year BS-MS students and those below 18 years of age. For others, an opt-in choice shall be given to stay in non-segregated hostels, and the rules for such stay can be worked out in consultation with all stakeholders with the proviso that such rules are implementable.</p> <p>In subsequent developments, the following definition for a gender segregated hostel has been shared with the students, "<i>as a building, or portion of building, intended for stay of students of a particular gender, for which the institute will adopt measures to regulate entry of individuals of other gender(s) by means in addition to that of a code of honor</i>".</p> <p>A draft letter of consent has also been prepared for students to exercise an option to stay in a non-segregated hostel (see Annexure III of the Agenda), but the Students Representative Council (SRC) has raised objections to the clause therein on information to be sent to parents / guardians and has also indicated that the option should be of the opposite kind, that is, from students who wish to stay in segregated hostels.</p> <p>Legal opinion has been sought on the matter of the Institute's responsibility / liability arising out of the existing arrangement of students staying in gender non-segregated hostels, should instances occur of gender harassment or of a student tragedy in the hostel (see Annexure III-A of the Agenda). The legal opinion indicates that, with the existing arrangement, vicarious responsibility/ liability will certainly devolve on the authorities i.e. BoG and the Director, in complaints of sexual harassment in hostels or if a tragedy were to arise therefrom (see Annexure III-B of the Agenda).</p>

	<p>Furthermore, since the procedure for creation of separated Boys' and Girls' wings in a single building has required the placement of partitions in hostel corridors on all floors, an apprehension has been raised about possible impediments for safe exit of students in case of fire. 


Dr Sunil Patil's team developed a **wall-mounted modular system** design that can be applied to treat different wastewaters from households, hotels, or small industries that lack access to a wastewater collection network. Multiple modular units, each a cuboidal or cylindrical-shaped reactor made of different lightweight materials, are mounted on a wall or vertical support. The modular units are connected in a serial hydraulic flow mode.
